The following Terms conditions & list of common and rare food items were approved by the committee

### Terms & Condition:-

- Contractor will bring / provide the following Items:
  - a. Deep Freezer & Refrigerator (Brand New).
  - b. Cooking Range (Brand New).
  - c. Micro-Wave Oven (Brand New).
  - d. Chips Boiler Machine with Chip Cutter (Brand New).
  - e. Glass showcase for display of items (Brand New).
  - f. Utensils/Crockery (New).
  - g. Furniture and fixture if required (New).
- h. The contractor will install ACs in Hall and curtains to windows.
- Canteen will be kept open from 07:00 AM to 08:00 PM. Seven days a Week.
- Call Deposit of Rs. 50,000/- deposit will remain with the College authorities as Security Deposit and will be refunded after three months after the expiry of contract.
- The contractor will maintain quality of food and services up-to the Satisfaction of the 4. administration/students. However, a penalty up-to maximum to Rs. 500/- per complaint will be imposed subject to the verification by the administrations / Canteen Committee.
- The Contract will be for a period of one year extendible to three years on rental basis. 5.
- Management reserves the right to terminate the contract at any time on one month' notice. However, the 6. contractor will give one month prior notice in writing if he desires to vacate the canteen before the expiry of contract with cogent reasons.
- Edible oil of best quality (I.S.O Certified) will be used for cooking. No recycling of any cooked item shall be 7. allowed.
- Good quality milk will be used for Tea/Coffee & no whitener will be allowed. Duly recommended by committee.
- Kitchen:
  - In the Kitchen the Chef will be wearing the Special Chef dress including Chef Cap. Chef Gown and gloves.
  - In the Kitchen the Case.
     The Person or Contractor who is responsible for handling of the food items shall wear Chef Cap. Chef Gown
  - and disposable gloves on the counter.

    If found guilty/misconduct or involved in any illegal activities or sale of any drugs/narcotics, shall be liable for police case and contract will be considered terminated with immediate effect.

Screening virology of all the kitchen/ staff will be on regular basis.

A CCTV camera will install in the kitchen and display will install in the students area.

- 10. Contractor will be responsible for cleaning, dusting, and washing of Chairs / Tables of Canteen, Hall, Kitchen and front arms
- 11. Contractor will be responsible for keeping the entire canteen and kitchen Premises neat and clean. A penalty of Rs. 5 000 - will be observed if Rs. 5,000 - will be charged if any

Complaint will be noted during the surprise visit of the management canteen Committee

- 12 The Contractor will not be allowed to sub-let the work to any other firm(s) person(s) or contractor(s). 13.
- All Items will be at market (KMC + Campus) price rates. Administration will ensure market price at any time.

  All Diffus bills, will be done of every month. 14.
- All Utility bills will be the responsibility of Contractor, and will be deposited within due date of every month. Rent of the canteen will be fixed at Rs. 50,000/- per month and bidding will be done for the price of the food items tent will be deposited up 5th. 15. items, rent will be deposited on 5th of advancing month, with 10% rent increase after every year.
- 16. Items list was provided in pre-bid meeting which was held on 21 06 2019 at 10:00 AM.

A food committee will be constituted to determined prices of the food items.

- 18. KCD food committee will decide about the award of contract keeping in view quality of food items and experience of the contractor.
- 19. Police verification and clearance of contractor will be carried out before award of contract letter.
